- Subcontractors in the framework of the random checks of DOIs against published sources, journal publishers in the framework of the conflict of interest management for scientific publications.

Data collected in your Declaration of Interests will be kept within the ESC database for 10 years or longer if they are related to a publication or a mandate within the ESC which remains still current. Data included in a publication will also remain available as part of the published material as long as

the latter is available.

In accordance with the chapter 3 of the European Regulation 2016/679 with regards to data protection, you and your spouse/partner have the right to request from ESC, access to and rectification or erasure of your personal data or restriction of processing concerning your data or to object to processing as well as the right to data portability.

<sup>1</sup> Spouse/partner or spouse equivalent is defined, for the purpose of completing this declaration, as a domestic partner or a person with whom you cohabit and/or share a stable relationship, generally equivalent to that of a spouse/partner. This is not limited to those relationships where there is a formal agreement or registered partnership.

<sup>2</sup> Healthcare industry: Any legally incorporated, revenue-driven entity engaged in direct commercial/profit activities within the healthcare sector. Examples: Pharmaceutical companies, medical device manufacturers, imaging companies, biotechnology firms, diagnostic service providers (e.g. core laboratories), digital health companies, profit medical education organisations, and profit contract research organisations (CROs).

For the purpose of filling out this form, healthcare industry excludes health service delivery such as private and public hospitals, universities, institutions, and charities focusing on direct patient care and clinical decision-making—and, by extension, professionals employed in these settings: physicians (general practitioners and specialists), nurses and allied professionals (including paramedics, hospital pharmacists, rehabilitation/clinical social workers/mental health counsellors), physician assistants, emergency medical technicians (EMTs) & healthcare administrators (within healthcare institutions).

<sup>3</sup> Public funding includes funds received from local, national, or international (e.g. EU) government-funded entities including direct branches of government and institutions or foundations financed by governmental entities. This also includes funding received from not-for-profit charities and foundations not directly funded by cardiovascular diagnostic, pharmaceutical, or device industry. Such organisations typically organise an independent expert review process prior to deciding on funding. Examples for such charities are the British Heart Foundation, Dutch Heart Foundation, Deutsche Herzstiftung, and many others. This does not include funds received by private corporations or companies or their subsidiaries. Such funding needs to be reported as industry funding.

<sup>4</sup> Entity does not refer to your (or your spouse/partner's) department, university, institution. Control of an entity, such as an organization or business, exists when one has, directly or indirectly, the power to direct or cause the direction of the management and policies of an entity, whether through ownership of voting securities, by contract, by beneficial ownership, or otherwise, e.g., trust funds.

<sup>5</sup> If the exact amount of travel funding is not known, please estimate.

<sup>6</sup> Travel funding that supports or complements activities disclosed in Sections 2 and 3 and/or honoraria should be reported within those sections, not here.

A financial interest 'beneficially owned' is one where an individual or entity has the right, in a company or sector, to some or all of the benefits of ownership. These include rights to direct the voting, detailed investment decisions within a mutual fund, or to receive the benefits of ownership.
